1. **Arghakhanchi Hospital Development Committee** has *allocated funds* towards the cost of **Procurement and Supply of X-Ray Items** and intends to apply part of the funds to cover eligible payments under the Contract for **Procurement and Supply of X-Ray Items (AH-G-NCB-03-2083/84)**. Bidding is open to all eligible Bidders as defined in ITB Clause 4 (Eligible Bidders).
2. **The Arghakhanchi Hospital, Sandhikharka** invites **electronic bids from eligible bidders for the Procurement and Supply of X-Ray Items** under National competitive bidding – Single Stage Single Envelope procedures.
3. Eligible Bidders may obtain further information and inspect the bidding documents at the office of **Arghakhanchi Hospital, Sandhikharka** or may visit PPMO egp system www.bolpatra.gov.np/egp.
4. Bidder who chooses to submit their bid electronically may download the bidding documents for e-submission from PPMO's (www.bolpatra.gov.np/egp) at no cost.
5. Electronic bids must be submitted through PPMO's e-GP system www.bolpatra.gov.np/egp on until **10:00AM on 8th September, 2026**. Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at **10:05 AM, 8th September, 2026** at the office of Arghakhanchi Hospital. Bids must be valid for a period of **90 days** from the bid submission deadline and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NPR **40000** which shall be valid for 30 days beyond the validity period of the bid (i.e. **till 5th January, 2027**).
7. If the last date of purchasing and /or submission falls on a public holiday applicable to purchaser, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
8. Arghakhanchi Hospital Sandhikharka reserves the right to accept or reject, wholly or partially.
9. The person, firm or company black listed as per Public procurement Act-2063 with amendment, shall be ineligible to submit the bid and also the proprietor of such firm or company shall be ineligible to submit the bid from another firm or company.
10. Matters not covered by this notice shall be in accordance with Public Procurement Act-2063 with amendment and Public Procurement Regulations-2064 with amendment and other prevailing regulations.
